



### **ABOUT LAWA**

Los Angeles World Airports (LAWA) operates Los Angeles International Airport (LAX), Van Nuys Airport (VNY), and Palmdale Land Holdings (PMD). The agency is governed by a seven-member Board of Airport Commissioners, appointed by the Mayor and confirmed by the City Council. LAWA has over 3,000 employees that manage operations, policy, and enforcement with a commitment to excellence. LAWA's strategic priorities are developing a people first culture, transforming LAX into a world-class global gateway, leveraging LAWA's economic impact to foster economic opportunity and ensuring a safe, secure and effortless guest experience.

LAX, one of the busiest airports in the world with more than 75 million annual passengers, and VNY, one of the nation's busiest general aviation airports, are vital to meeting Southern California's passenger, cargo, and general aviation needs. LAX is undertaking a \$30 billion capital improvement program to deliver new world-class facilities, including an Automated People Mover, and a Consolidated Rent-A-Car facility, as Los Angeles prepares to host the Olympic Games in
